VAGINAL PESSARIES

COMPOSITION

Each 2 g vaginal pessary contains: aloe barbadensis oil extr. 60 mg, colloidal silica 30 mg, lactic acid 1 mg, potassium chloride 4 mg, disodium edetate 3 mg, PHMB hydrochloride 15 mg (sol. 20%), semi-synthetic glycerides 1847 mg, purified water 40 mg.

CATEGORY

Medical device.

PROPERTIES

BIGUANELLE[®] Pessaries consists of a base of semi-synthetic glyceride which breaks down rapidly in the vagina, facilitating the release of the components. The product is preserved with polyhexanide (PHMB), a cationic surfactant well tolerated in the mucosa. BIGUANELLE[®] Pessaries allow the restoration and subsequent maintenance of natural vaginal pH and physiological conditions, it lubricates the vaginal mucosa and aids the re-epithelialization processes

CLINICAL INFORMATION

INDICATIONS

BIGUANELLE[®] Pessaries is indicated for the treatment and prevention of vaginal infections. Restores and maintains the natural physiology of the vaginal environment.

CONTRAINDICATIONS

Known hypersensitivity to the components.

SIDE EFFECTS

In some cases, intolerance (burning or irritation) may occur, but without consequences, which does not require any modification in the treatment. Report your doctor or pharmacist of any undesirable effect you suspect may be caused by using the product.

EFFECTS ON DRIVING OR USING MACHINES

No effects on the ability to drive vehicles or use machines have been reported.

METHOD OF ADMINISTRATION

1. Wash your hands thoroughly before opening the pack. **2.** Take a single cavity from the blister pack and try not to damage the remaining cavities. **3.** Remove the pessary from the cavity. **4.** Gently insert the pessary into the vagina, inserting it deep enough to prevent the product from accidental leaking out.

DOSAGE

One pessary in the evening for 10 consecutive days. The treatment can be repeated.

WARNINGS

Use of all topical products particularly for extended periods of time, can lead to sensitisation; if this occurs, discontinue the treatment and consult your doctor to set up proper therapy. If you are scheduled to undergo specific gynecological tests or treatments, discontinue the treatment the day before. The product should be only administered vaginally. Under normal conditions of use, no cases have been reported of damage caused by overdose. Do not use the product if you are allergic to any of the ingredients. Using during pregnancy should be limited to cases of real necessity and under medical supervision. Do not use the product after the expiry date indicated on the packaging. Do not use the product if the package is not intact. Keep out of reach of children. Do not swallow.

SPECIAL PRECAUTIONS FOR STORAGE

Store at a temperature between 0 and 25 °C, in a dry dark place.
